Regulations concerning the entrance and membership fees of the PUBLIC ORGANIZATION "CHINESE IMAGE MEDICINE ASSOCIATION of UKRAINE" in accordance to the Statute of the PUBLIC ORGANIZATION "CNINESE IMAGE MEDICINE ASSOCIATION of UKRAINE". Regulations Position on the entrance and membership fees of the PUBLIC ORGANIZATION "CHINESE IMAGE MEDICINE ASSOCIATION of UKRAINE", the order of payment the entrance and membership fees determines by the members of epy PUBLIC ORGANIZATION "CHINESE IMAGE MEDICINE ASSOCIATION of UKRAINE".

MEANING OF THE TERMS

Terms, including those starting with the capital letter, are used in this Statute in a next meaning:

The Association - is PUBLIC ORGANIZATION "CHINES IMAGE MEDICINE ASSOCIATION of UKRAINE".

Payments - are entrance, membership (annual) and targeted payments as an unreturnable financial help financial help, the sum and order of these payments are set by this Statute.

Regulations – are the Regulations on the entrance and membership fees of the PUBLIC ORGANIZATION "CHINESE IMAGE MEDICINE ASSOCIATION of UKRAINE".

1. GENERAL REGULATIONS

1.1. The members of The Association pay the entrance fee when joining The Association and in future pay current (annual) membership dues.

1.2. Payments are paid in the monetary item of Ukraine -Hryvnya (UAH), by depositing the money to the settlement account of The Association or to the cash register of The Association.

1.3. The money received as payments from the members of The Association are used by The Association for realization of its statute aim and tasks, processing of necessary membership documents and maintenance of executive branches, development of material and technical base and realization of projects and programs.

2. CONTRIBUTORS

2.1. The contributors are all the members of The Association, included in the general register of The Association's members.

3. DUTIES and RESPONSIBILITY of CONTRIBUTORS

3.1. Contributors – the members of The Association are obliged to make full payments in time.

3.2. Contributors - the members of The Association bear responsibility for timeliness of making payments in front of the Association.

3.3. Control after the timeliness of making payments is carried out by the Chairman of the Governing Board (The Chairman of The Association).

3.4. For non-payment (ill-timed and/or incomplete payment) of the payments the member of The Association can be expelled from the members of The Association.

4. SUM OF PAYMENTS

4.1. The sum of annual membership fee is 1 000 (one) thousand UAH.

4.2. Joining The Association every member of The Association pays the entrance fee in sum of 1 000 (one) thousand UAH and that counts as an annual membership fee.

4.3. To the students, pensioners, invalids and other preferential categories of people, according to the decision of the Governing Board of The Association, can be set the individual sum of the entrance and membership fees.

4.4. If cancelling (expelling) being the member of The Association, payments do not return.

5. ORDER AND TERMS OF THE FEE PAYMENTS

5.1. The fee payments are made by the members of The Association by depositing the money to the settlement account of The Association or to the cash register of The Association.

5.2. The entrance fee is paid by the member of The Association, in a term that does not exceed 1 (one) month from the moment of getting the Decision of the Governing Board of the Association about the accession to the membership.

5.3. An annual membership fee is paid in a term that does not exceed 2 (two) months from the beginning of the year for which the payment of annual membership fee is being made.

5.4. Not later than 30 (thirty) days to completion of the payment term of annual membership fee the Chairman of the Governing Board (Chairman of The Association) or his/her representative, sends the message to the members of The Association, about the payment of annual membership fee.

5.5. Payments are considered paid from the moment of the money income in determined size to the settlement account of The Association or to the

cash register of The Association.

5.6. As evidence of payment the fee, the member of the Association keeps for him/herself payment with the mark of bank establishment and/or receipt and/or cashdesk order.

5.7. In case of non-payment the fees by the member of The Association in a term that exceeds 2(two) months from the moment of the set term of the payment, without the appropriate decision of the Governing Board of The Association, in decision of the Governing Board of The Association a person is expelled from the members of The Association, about what he/she will get the message.

5.8. Membership in The Association can be renewed by the repeated entrance into The Association on condition of payment of annual membership fee.

5.9. An account and control after the payment of the fees is made by the Chairman of the Governing Board (By the Chairman of the Association).

6. EXEMPTION FROM PAYMENT of FEES, REDUCTION in the SUM of PAYMENTS, POSTPONEMENT of the FEE PAYMENT

6.1. In cases envisaged by this Statute, according to the decision of the Governing Board of The Association the privileges in fee payment can be given to the members of The Association:

6.1.1. postponement of the fee payments;

6.1.2. reduction in the sum of payments;

6.1.3. exemption from payment of fees.

6.2. The decision about giving the privileges envisaged by p. 6.1. of this Statute, is accepted by the Governing Board of The Association separately in every single case based on the application given by the member of The Association.

6.3. According to the Checkup Committee (Inspector) presentation, the Chairman of the Governing Board (the Chairmen of The Association), the Governing Board of The Association can decide to give some privileges in the fee payment to the members of The Association, who has given great material, organizational, technical help in the activity of The Association. In such case, giving the application asking for some privileges is not required.

6.4. The postponement of the fee payment envisages the postponement of the set payment term according to the application of the member of The Association, on a term that does not exceed 6(six) months from the moment of the ordinary term of fee

payment, on condition that the reason that became the basis for giving the appropriate application is accepted by the Governing Board of The Association.

6.5. According to the application of the member of the Association, the Governing Board of The Association can decrease the sum of payments that must be paid by the member of The Associations, or exempt the member of The Association from the fee payments.

6.6. The reasons for giving privileges envisaged by p. 6.1 of this Statute to the member of The Association, can be:

6.6.1. unsatisfactory financial position of the member of The Association;

6.6.2. massive activity in realization of the statute aims, programs and tasks of the Association, etc.

6.7. Application about the privileges concerning the fee payments is addressed to the Chairmen of the Governing Board (the Chairmen of The Association) in a written form and is considered by the Governing Board of The Association in a term that does not exceed 1(one) month from the moment of presentation and registration of the application in set order.

6.8. The decision of the Governing Board of The Association about granting or refusing in privileges set to p. 6.1. of this Statute, is sent to the member of The Association by the recommended postal mail and/or handed personally. The decision cannot be appeal.

7. SPECIAL PURPOSE PAYMENTS

7.1. Special purpose payments are paid by the members of The Association for financing its separate programs.

7.2. Special purpose payments are:

7.2.1. obligatory for the payment of all the members of The Association in case of approval such a decision by the General Meeting of The Association;

7.2.2. voluntary for the payment of the members of The Association that gives them a right for participating in the certain program of The Association and using its results.

7.3. The sum of the special purpose payment becomes firmly established by the Governing Board of The Association.

7.4. Sums of the obligatory special purpose payments are identical for all the members of The Association. Sums of voluntary special purpose payments can be different for the members of The Association.

7.5. The members of The

Association pay voluntary special purpose payments in a term set by the

Governing Board of the Association. In case of non-payment (incomplete payment or ill-timed payment), the member of The Association is deprived of the right (limited in a right) to participate in the certain program of The Association and use its results.

8. APPROVAL, MAKING CHANGES AND ADDING TO THIS STATUTE

8.1. Statute becomes valid from the moment of its statement by the Governing Board of The Association.

8.2. Changes and adding to this Statute are made according to the decision of The Governing Board of The Association or the General Meeting of The Association, that is recorded in a protocol.

8.3. All the questions, unresolved in the Statute of The Association, or by the Statute and internal documents, are decided according to the requirements of the current legislation of Ukraine.
